<u>ClinicalTrials.gov</u>Pre-Notices for Potential Noncompliance:

The FDA is now **publicly posting a list** of organizations and investigators that have received a **Preliminary Notice of Noncompliance (pre-notice)** related to potential noncompliance with federal requirements for registering and submitting to ClinicalTrials.gov. This is the first time that this list has been made public and will be updated quarterly. Issues of potential noncompliance include:

- Failing to register an applicable clinical trial.
- Failing to submit required clinical trial information for an applicable clinical trial.

Submitting false or misleading clinical trial information.

The pre-notice should be addressed within 30 days of receipt. If it is not addressed the FDA will issue a notice of noncompliance.

OnCore Clean-up to the Financial Modernization Project:

An OnCore data clean-up is underway in preparation for the <u>Financials</u> <u>Modernization</u> Project. Current changes include but are not limited to the Main/Management tab and PC Console:

- The "Internal Account No." field must contain the KFS Account number.
- KFS# must be 7 characters including only numbers, no letters. If there is an associated subaccount, please utilize the "Hospital Account No." field.
- If the KFS# is pending assignment, "Pending" must be listed in the Internal Account No. field.
- Internally funded studies should list "Internal" if there is no KFS#.

Scheduling for PET & MRI Scans:

Please be aware of your subject's study windows if they require a MRI or PET and avoid having a protocol deviation.

PET scheduling for any type of patient, clinical or research, is out **6-7 weeks.** The best advice is for study teams to schedule as far in the future as possible. With the single PET scanner and such a high clinical need, it will be hard for Imaging to guarantee that studies can meet the windows on short notice.

Due to the MRI scanner being replaced at Main Campus (Tucson), the first available appointments for outpatient MRI are in December 2023. North Campus has MRI availability, this is where 80% of outpatients are scheduled.
