OnCore UAHS RA Sign-off Workflow Change:

Our office is updating the OnCore UAHS RA Sign-off workflow to have study calendars built upon Coverage Analysis (CA) completion.

This will allow for study teams to validate calendars earlier in the process, so calendars are ready to use once a study is open to accrual.

Requirements for OnCore UAHS RA Sign-off include:

- IRB approval
- Final ICF upload
- Budget (as applicable)
- Fully executed contract (as applicable)

University of Arizona - Banner Badges:

For compliance reasons, your University of Arizona badge should always be worn over your Banner badge. Your Banner badge is only for access, not identification while in the facility conducting research related duties.

UA IRB Submission Review Times:

UA IRB is experiencing a high volume of submissions right now. The current average time to **HSPP** reviewer assignment is approximately 2-3 weeks. As a result, you may notice some delays in response times. Please ensure that you allow sufficient time for review of your submissions.

If your submission is urgent, please contact <u>UA IRB</u> and they will do their best to prioritize it.

OnCore Data Review & Clean-up:

As a part of our continued efforts to ensure compliance in medical billing, educate and support to our OnCore users, the OnCore Support team has initiated an auditing process to review subject visit logging in OnCore.

This will also include:

- Clean-up of general information
- Stagnant study statuses
- Uploads of required documentation
- Summary Accrual information
- Unlogged Visit Audits
