OnCore Billing Compliance Requirements:

- **Compliance:** The billing designation is set using Medicare Billing rules, input from PI, approval by Banner (the medical biller), and the signed contract between the sponsor and the University of Arizona.
- **Financial Equality:** Each procedure must be billed the same way for all subjects. If a procedure is billed to insurance for one subject, the sponsor cannot pay for that same procedure for another subject.
- The **correct** billing designation is built into the OnCore calendar, so the CRC can confidently log visits and procedures.
 - If the CRC has a question or concern about a billing designation, please reach out to OnCore Support (OnCoreSupport@arizona.edu), so we can review the situation and discuss with the coverage analysis/budget team.

Inability to follow the requirements will result in remediation including training and supervisor inclusion.

OnCore UAHS RA Sign-off Workflow Change:

Research Administration is updating the OnCore UAHS RA Sign-off workflow to have study calendars built upon Coverage Analysis (CA) completion.

This will allow for study teams to validate calendars earlier in the process, so calendars are ready to use once a study is open to accrual.

Requirements for OnCore UAHS RA Sign-off include:

- IRB approval
- Final ICF upload
- ICF Congruency Review may take 3 business days. Please submit to crc@arizona.edu as soon as IRB approved.
- Fully executed contract (as applicable)
- Budget (as applicable)
